INVITATION

Southport Yacht Club extends a warm invitation to owners, skippers and crews of all eligible boats to enter and compete in the 2022 Qoin Sail Paradise Regatta to be sailed on Windward / Leeward, Triangle and Passage type courses on the ocean waters off Main Beach & the Surfers Paradise coastline from the 3rd to the 6th January 2022.

ORGANISING AUTHORITY

The Organising Authority shall be Southport Yacht Club Inc. (SYC) located at 1 Macarthur Parade, Main Beach QLD 4217. Phone (07) 5591 3500.

1 RULES AND REGULATIONS

- 1.1 The Regatta will be governed by the rules, unless modified by the Sailing Instructions (SI), as defined in:
 - 1.1.1 The Racing Rules of Sailing (RRS) of World Sailing (WS)
 - 1.1.2 Special Regulations of Australian Sailing (AS) Part 1 Category 6
 - 1.1.3 IRC rules Parts A, B, C (including the AS prescriptions) where applicable.
 - 1.1.4 OMR Rating Rules where applicable.
 - 1.1.5 ORC Rating Rules where applicable (ORC Club).
- 1.2 RRS 52 MANUAL POWER does not apply.
- 1.3 Boats not racing in an IRC Class (that allows variable and/or movable ballast) shall request permission from the Race Committee to use movable and/or variable ballast for the purpose of increasing stability. Any such request must be accompanied by full details of the system involved, and any such system will be taken into account in establishing the boat's handicap. Stored power may be used for the operation of movable ballast systems. RRS 51 is modified to the extent required by this paragraph.
- 1.4 Boats entered in the Non-Spinnaker Class shall not carry spinnakers or Code Zero sails but may use a spinnaker pole to pole out one headsail. Headsails shall be fully hanked or attached to the main forestay by the means of a luff groove device.
- 1.5 Nothing in the Notice of Race (NOR) or Sailing Instructions relieves a boat of her responsibility under civil law to comply with the International Regulations for Preventing Collisions at Sea or local regulations.
- 1.6 Between sunset and sunrise, when a boat cannot determine with certainty what tack the other boat is on, she shall keep clear of that boat. Competitors are reminded that part of the definition of "room", includes taking into account the existing conditions (including visibility).
- 1.7 The owner and skipper of all boats shall ensure that no entities form unauthorised associations between themselves (and their products or services) and the event (otherwise known as ambush marketing") or any "hijack signage" is carried out by or on behalf of themselves or their sponsors with reference to the event and that nothing else is done which might undermine the event, the rights of the event sponsor, or any other sponsor or participant in the event.
- 1.8 Before the first race of the Regatta, all boats in IRC Division shall submit to the Sailing Office a declaration of all the sails carried on board for the duration of the Regatta (IRC Rule 21.1.5(d)).
- 1.9 Boats shall not use boat tracking, photography, or video for commercial purposes without prior written approval of the organising authority.
- 1.10 When conflict occurs between the Notice of Race (NOR) and the Sailing Instructions, the rules of the Sailing Instructions shall prevail. This changes RRS 63.7.
- 1.11 RRS Appendix T Arbitration will apply.
- 1.12 Current Covid-19 Safe Plan in Place. We are compliant in accordance with the "Aquatic Sport Sector Industry COVID Safe plan", for Yachting QLD (Sailing) small off the beach craft & yachts. At all times, the Plan is subject to all regulations, guidelines, and directions of Government and Public Health Authorities. Protocols as set out by the Organising Authority, include online pre-registration for the event as detailed in "Attachment C" of the Sailing Instructions.

2 SAILING INSTRUCTIONS

The Sailing Instructions will be available online at www.sailparadise.com.au and at Registration.

3 NOTICES TO COMPETITORS

The Official Notice Board will be the online Notice Board located on the event website https://www.sailparadise.com.au/notice-board/ Additionally, a physical display shall be located at Southport Yacht Club, Main Beach, adjacent to Reception.

4 ELIGIBILITY OF BOATS

The Regatta is open to boats that meet the following entry requirements.

- 4.1 All boats shall:
- 4.2 Comply with the AS Special Regulations Part 1 for Category 6 events. Spot check audits may be conducted at random by the OA at any time throughout the Regatta.
- 4.3 Be registered with a Yacht Club affiliated with its National Authority.
- 4.4 Shall hold a current Public Liability and Third-Party Insurance Policy to the value of not less than AUD\$10 Million, which includes coverage for racing in the Regatta.
- 4.5 Requirements for Monohull Boats
 - 4.5.1 Be built in accordance with the AS SR Part 1, Section 3.03
 - 4.5.2 Satisfy the stability criteria of the AS SR Part 1, Section 3.04
- 4.6 Requirements for Multihull Racing Boats
 - 4.6.1 Submit an OMR rating certificate ratified by MYCQ and listed on the MYCQ register at www.mycq.orq,au
- 4.7 Competitors may enter one of the following Handicap Categories:
 - 4.7.1 **International Rating Certificate (IRC)** Racing Monohulls which have a current valid endorsed IRC Certificate which is required to be submitted with their entry.
 - 4.7.2 **Performance Handicap System (PHS)** *Racing Monohulls* will be divisionalised to have like boats sailing together.
 - 4.7.3 **Performance Handicap System (PHS)** *Cruising Monohulls Non-Spinnaker* will be fitted out to cruising standards and will typically not have working sails of custom-built exotic construction and boats shall not be stripped or lightened.
 - 4.7.4 **Performance Handicap System (PHS)** *Cruising Multihulls* will be fitted out to cruising standards and will typically not have working sails of custom-built exotic construction and boats shall not be stripped or lightened.
 - 4.7.5 **Class Base Handicap (CBH)** *Trailable Yachts* which are able to be trailed, launched and retrieved on a road-legal trailer.
 - 4.7.6 **Offshore Multihull Rule (OMR)** *Racing Multihulls* which have a current valid endorsed OMR certificate which is required to be submitted with their entry.
- 4.8 Offshore Racing Congress Club (ORCc) Racing Monohulls & Trailable Yachts which have a current valid endorsed ORC Certificate will be scored in their relevant IRC & PHS Handicap Categories. A copy of this certificate will also be required to be submitted with their entry.
- 4.9 For all One Design Classes, a boat shall not change specifications after the close of entries. Any change to the hull, spars, sails, foils, ballast, equipment or any other factor which may affect the performance of the boat may be made only with the express written consent of the Race Committee
- 4.10 The Race Committee may create Divisions within Handicap Categories and allocate boats to divisions within a Handicap Category at its sole discretion.
- 4.11 The Organising Authority may cancel any Handicap Category if fewer than seven entries have been received by the closing date. In this event, boats that have entered will have the option of transferring to another Handicap Category (if eligible) or having their entry fee refunded.

5 ENTRY, FEES AND DOCUMENTATION TO BE LODGED

- 5.1 Eligible boats shall enter via the Qoin Sail Paradise online website located at www.sailparadise.com.au and submitted online via the Topyacht Entry System accompanied by the required Entry Fee/s and supplementary documentation, as applicable.
- 5.2 An "Early Bird" Race Entry Fee for the 2022 Qoin Sail Paradise Regatta shall be \$250.00 for all Divisions entered prior to midnight on October 31st, 2021.
- 5.3 The Race Entry Fee for the 2022 Qoin Sail Paradise Regatta for entries received after 31st October 2021 up to and including 12th December 2021 shall be \$300.00 for all Divisions.
- 5.4 Entries received after the 12th December 2021 will incur an \$80 late fee.
- 5.5 Entries shall be lodged with the Organising Authority no later than 1700 hours on the 31st December 2021. NO ENTRIES WILL BE ALLOWED AFTER THIS DATE.
- 5.6 An entry is not valid (Refer RRS 76.1) until all of the appropriate documentation and fees have been received and approved by the OA.
- 5.7 The OA is not responsible for any failure of, or errors, in the information provided by the TopYacht Entry System.
- 5.8 Crew Particulars, including Australian Sailing Numbers, Emergency Contact Names and Contact Numbers must be submitted via the TopYacht Entry System and are required by 1700hours on 3rd January 2022.
- 5.9 Where the person-in-charge of a boat is under the age of eighteen (18) years, their Parent or Guardian shall complete & submit the Parent/Guardian Declaration Form at time of online entry.
- 5.10 Class Measurement and Rating Certificates, as required.
- 5.11 For a boat entered in a One-Design Class, the document(s) specified as required by its One-Design Rules and Regulations.
- 5.12 A list of entries will be available online www.sailparadise.com.au

Personal Information about crew members is obtained from the crew lists. The information may be provided to Search and Rescue (SAR) authorities and organisations, the Water Police and Volunteer Marine Rescue personnel. A condition of entry is that the Person in Charge must inform all crew members that their personal information may be used for SAR purposes and advise that they may obtain access to their personal information by contacting the OA.

6 EVENT ADVERTISING

Boats shall display event advertising supplied by the organizing authority which may consist of Boom Stickers, Bow Numbers and / or Pennant Flags.

8 VENUE

The Regatta will be conducted from Southport Yacht Club (SYC) located at 1 Macarthur Parade, Main Beach, Qld 4217. Phone: (+61) 7 5591 3500

9 COURSES

The courses shall be Triangle, Windward/Leeward, Ocean Marks and Passage Course configurations, as described in the Sailing Instructions. Cruising Divisions will sail predominantly Passage Courses.

10 PENALTIES

- 10.1 Alternative Penalties For windward/leeward courses the two-turns penalty (RRS 44.1) is changed to a one turn penalty, except for infringements that occur within the zone.
- 10.2 Event Nominated Penalties shall be a 20% scoring penalty. This will not be grounds for a protest by a boat. This changes RRS 60.1(a). The scoring abbreviation for an Event Nominated Penalty under this instruction will be ENP. The penalty shall be applied to the race sailed nearest, in time to that of the breach. This changes RRS Rule 60, A4 and A5.

11 SCORING AND HANDICAPS

- 11.1 The scoring system shall be the Low Point System, RRS Appendix A.
- 11.2 Two races must be completed to constitute a series.
- 11.3 When fewer than 6 races have been completed, a boats series score will be the total of all her race scores.
- 11.4 When 6 to 8 races have been completed, a boats series score will be the total of her race scores excluding her worst score.
- 11.5 The following Divisions will be scored by the listed Handicap Systems:

11.6 The Performance Handicap System starting handicap (AHC) for each boat will be determined by the Southport Yacht Club Handicap Committee. The decision of the Handicap Committee or the representative on any handicap matter will be final and will not be grounds for requests for redress. This alters RRS 60.1 (b).

12 BOAT IDENTIFICATION

All Boats will be issued Divisional flags by the Organising Authority. Flags shall be flown astern.

13 BERTHING

All boats competing are encouraged to berth or raft up along the beach at SYC Main Beach for the duration of the Regatta as this is where the social events will be held. SYC offers limited FREE berthing and rafting space to competing yachts from 2pm Sunday 2nd January 2022 through to 10am Friday 7th January 2022. However, **MARINA BERTHING AT SYC IS LIMITED**, please arrange berthing directly with the SYC Marina Office: ph: (07) 5591 3500. Rafting space for One Design Classes and Trailables may be along the beach in front of the club and rafting may be required in the larger Marina berths.

14 HAUL-OUT RESTRICTIONS

All boats shall not be hauled out during the Regatta except with and according to the terms of prior written permission of the Race Committee.

15 DISCLAIMER OF LIABILITY

- 15.1 The Organising Authority, the Race Committee, the event sponsors and their respective representatives, officers, members and volunteers accept no liability whatsoever for any loss of life, property, personal injury or damage caused by or arising from the Qoin Sail Paradise Regatta.
- 15.2 By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes. Attention is drawn to RRS 3 "Decision to Race" which states "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone."

16 INSURANCE

Each participating yacht shall be insured with valid third-party liability insurance with a minimum cover of \$10, 000, 000.00 per incident or the equivalent, which also includes coverage for racing in the Regatta. Proof of Insurance may be required, clearly indicating the person, the amount and the period of coverage, at registration. All owners/competitors who complete an Entry are deemed to have made this declaration that they hold such coverage.

17 PRIZES

- 17.1 Daily prizes will be awarded for IRC, ORC Club, PHS & OMR handicap scores for 1st, 2nd and 3rd on corrected time in each race, for each Division, except if there are multiple races held for a Division, the day's totaled race scores will determine the winners.
- 17.2 The Qoin Sail Paradise Trophy presentation will be staged asap after the last race on Thursday 7th January at Southport Yacht Club, Main Beach. This will include the presentation of the Qoin Sail Paradise Perpetual Trophy and the winner of the Gold Coast IRC Championships Perpetual Trophy.
- 17.3 The Qoin Sail Paradise 2021 Surfboard shall be awarded to the best performing overall Divisional boat (i.e. Any Divisional 1st place boat with the largest winning margin).
- 17.4 Other prizes may be awarded at the discretion of the Organising Authority.

7 RIGHTS TO USE NAME AND LIKENESS

By participation in an event, a competitor automatically grants to the Organising Authority and the sponsors of the event, the right in perpetuity, to make, use and show, from time to time and at their discretion, any motion pictures, still pictures and live, taped or film television and other reproductions of him/her during the period of the competition for said event in which the competitor participated and in all material related to the said event without compensation.

SUPPLEMENTARY INFORMATION

For QOIN SAIL PARADISE 2022

B.1 LAUNCHING

There are launching facilities at Main Beach as well as Hollywell. The Main Beach facility has a boat ramp and marina while the facility located at 1 Marina Crescent, Hollywell has a crane, boat ramp and boatyard for rigging. Hollywell is approximately 4 Nautical Miles to the North of the Southport Yacht Club Main Beach clubhouse and easily accessible by the channels of the Broadwater. Trailer Sailors are encouraged to leave their boats in the water overnight at Main Beach. No overnight berthing will be permitted on the marina at the Hollywell Sailing Squadron. There is no Mast Stepping Gantry available. Competitors are advised to bring their own A-frame or Gin Pole for stepping of masts, although equipment may be available to be borrowed from Gold Coast Etchells Fleet Members.

B.2 TRAILERS

Trailers may be kept on the grounds immediately adjacent to the SYC Hollywell Sailing Squadron by arrangement with the Sailing Office on Telephone (07) 5537 7030. Trailers may also be kept at the Eastern side of the Southport Yacht Club Main Beach car park by arrangement with the Marina Manager, on Telephone (07) 5591 3500. While all care is taken, no responsibility is assumed by Southport Yacht Club Inc for any property left on or around Club premises.

B.3 FACILITIES

Changing Rooms, Showers and Toilets are located at the Western Side of the Main Beach Clubhouse. Entry to the shower block requires an access card that also gives access to the Marina Security Doors. Access Cards are available from the Marina Office and require a security deposit, refundable upon return.

The Bosun's Locker Chandlery is located at the western side of the compound and stocks most common boat parts. There are several sailmakers located in close proximity to the Club.

B.4 HOSPITALITY

The Clubhouse has a Licensed Bar, a Restaurant offering a quality range of food at affordable prices, and patio seating overlooking the Broadwater. In accordance with Queensland Liquor Licensing Regulations, all visitors will need to produce identification and sign in. This is only required once for each day you visit the Clubhouse.
